#### MAJOR LEGISLATION TO WATCH IN 2020

Predicting what bills the General Assembly will pass, amend, or defeat is tricky business. With that in mind, consider these major 2020 legislative policy issues.

#### The State Budget

Gov. Brian Kemp, worried about declining revenue coming into state coffers, instructed many state agency heads to submit budget reduction proposals. In this context, some state lawmakers wonder why so many tax breaks for large corporations are being considered. While Georgia's economy has been growing in recent years, the 2019 General Assembly could only bring itself to pass a water-down version of bills sponsored by state Sen. John Albers, R-Roswell, which would have mandated the state take a closer look at special-interest tax breaks before lawmakers vote on them.

In 2018 legislators passed several special-interest tax breaks worth hundreds of millions of dollars. And earlier this year there were measures to provide tax breaks for Delta Air Lines and other air carriers as well as CSX and other railroads.

While the House leadership appears to support a fuel tax break for Delta and other airlines, Lt. Gov. Geoff Duncan and a state Senate majority remain opposed. Key senators interviewed by *James* question such breaks, especially since the loss of this significant revenue into state coffers from previous exemptions is now being felt.

The governor hopes to garner through budget cut savings \$200 million this year and \$300 million next year. A big question: How much of this will come from eliminating currently vacant jobs or because of high turnover rates in some agencies?

#### **Mass Transportation**

Legislation has already passed paving the way for transit expansion in 13 metro Atlanta counties. Seeking to expand statewide is a House-passed bill by Rep. Kevin Tanner now awaiting action in the Senate. It would allow counties to raise sales taxes for transit expansion. It also creates pilot programs to help unemployed residents get transportation to jobs, as well as combining six state agency transit functions into one new agency.

Earlier this year the tanner bill was opposed by the state Department of Transportation. GDOT said the mergers would have unintended consequences and thus seeks to preserve its transit functions. "GDOT is fully committed to being fully efficient and effective in all transportation programs," DOT Commissioner Russell McMurry says.

Watch for this bill to be tweaked and debated again.

#### A Hartsfield-Jackson State Airport Authority

The Senate passed a bill by Sen. Burt Jones, R-Jackson, creating a state authority to oversee Hartsfield-Jackson International Airport. It removes control over airport operations, especially its corrupt contracting system, from Atlanta's mayor. But the Senate and house Speaker David Ralston couldn't find common ground.

Last spring Ralston thought it "premature" to go with a state authority and just wanted a state airport oversight committee. Yet proponents note airport bid-rigging, vendor bribery and airport jobs for unqualified mayoral cronies span over 40 years – and that an oversight panel doesn't correct a continuing mess affecting the entire image of the state.

The bottom line: The bill is in a conference committee and there will be 12 days in January to ascertain if the Senate and house can agree to move the bill forward in whatever form. Or if it will die on the vine.

#### **E-Scooter Regulation**

The invasion of the electric scooters, which took Georgia cities by storm almost two years ago, caught local governments off guard. Users were getting attached to the service before regulations could be implemented to protect safety, whether on streets or sidewalks. Atlanta was especially unprepared – and many say it still is.

Last March state rep. Kevin Tanner, R-Dawsonville, told the state Senate Public Safety Committee that he was holding off on proposed statewide rules for e-scooters while negotiations with scooter companies continued in various locales. But regulations of electric bikes passed the committee by a unanimous vote and could be acted upon in January.

The Senate's study committee may develop basic rules of the road – especially where, when and how the devices can be used. Twenty-two states have some e-scooter regulation. According to a presentation to the Senate committee, many states set a statewide maximum speed for scooters at 15 or 20 mph. A major complaint is that the scooters block sidewalks and crowd out pedestrians. That's why Atlanta moved the scooters to the streets but, as this is written, four scooter street deaths have occurred since then. Some states impose age limits to operate the scooters and two require teenage riders to wear helmets.

So be ready for more rumblings about regulation during the 2020 General Assembly – although a consensus may be building among state legislators that localities are best at making their own decisions and/or regulations about electronic transportation options.

#### What Else?

Unlike years past, religious freedom legislation goes nowhere. Casino gambling will be up for debate, and the question to the General Assembly will be whether to put a constitutional amendment authorizing gambling on the ballot for voters to decide. Legislation by Sen. Brandon Beach, R-Alpharetta, and Rep. Ron Stephens, R-Savannah, would ask voters to approve a constitutional amendment legalizing destination casino resorts, pari-mutuel horse race wagering and even sports betting. All this would be tied to boosting revenues for the Georgia Lottery's popular HOPE scholarship.

Meanwhile, the governor's commitment to education will be on display to potentially increase HOPE funding and have additional teacher raises. And healthcare reform is always a topic.

Also look for legislation reforming so-called "criminal justice" laws that have loopholes allowing for the release of violent criminals. A Senate-passed bill would allow restoration of voting rights to "non-violent" felons. But it's not clear if that applies to categories ranging from drug pushers to burglars and shoplifters.
