FROM THE CHAIRMAN

The questions were not even "softballs," but as my favorite radio talk show host, Andrew Wilkow, called them, "whiffle balls." The questions appeared to be assigned in order beforehand and Mr. Biden had extensive notes to answer them. The questions were mostly nauseating, also - Yamiche Alcindor deserves whatever daily award liberals are giving themselves these days. Secretary of State Antony Blinken announced that the Biden administration will be reengaging with the U.N. Human Rights Council, from which the Trump administration withdrew in 2018. Although the council has sometimes advanced the cause of human rights, its authoritarian members – Russia, China, Venezuela, Cuba, an others – too often get a free pass, and it disproportionately criticizes Israel. These flaws are longstanding. What is new is that China has stepped up its attempts to coopt the body. The Biden administration believes that being in the room will allow it to push back against authoritarian influence. But the body should be fundamentally reformed before the U.S. lends legitimacy to it once again. "Diplomacy is back," says the Biden team, but we fear what they really mean is "complacency." WHAT TO EXPECT AT THE 2021 PRECINCT CAUCUSES AND COUNTY CONVENTION

Many of our newer members may not be aware of the significance of our upcoming Precinct Caucuses and County Convention set for Saturday, **April 17, 2021**, at the Winder Lions Club, 354 E. Broad St., Winder. The following is information to explain what will be happening on this important date.

Temporary Precinct Caucus Chairpersons will be appointed by the current Barrow GOP Chairman Debbie Reid. At 9:00 AM on April 17, these people will call the 8 individual precinct caucus meetings to order. All participants at these meetings must be duly registered in accordance with State Republican Party rules and Georgia State Election Code. The first order of precinct meeting business is to elect new Precinct Chairpersons for 2021-2023 (and other Precinct officers, if desired by the precinct participants). The new Precinct Chairperson will conduct the rest of the meeting. Each precinct meeting will then elect Delegates and Alternates to the 2021 Barrow County Republican Convention. All Delegates will receive name tags for Convention usage.

When all of the elections are completed, the paperwork (in triplicate) will be processed and routed to the appropriate local Party representatives. Other precinct business may take place at this meeting. It will be a good time to get acquainted with other Republicans in your precinct, and plans for future precinct work can be discussed.

At 10:00 AM on **April 17, 2021**, the current local Party Chairman Debbie Reid (serving as Temporary Convention Chairman) will call the 2021 County Convention to order. After the Pledge of Allegiance, Invocation, Presentation of the state call, and Introduction of Elected Officials, the convention will elect the 2021 Permanent Convention Chairperson and Permanent Convention Secretary. Convention committees will then be dismissed to conduct their work (Credentials, Nominations, Rules). During this time, there may be announcements and speeches in the convention hall.

After the Convention committees return and report, the 2021-2023 Barrow County Republican officers will be elected. These include County Chairperson, First Vice-Chairperson, Second Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer. The Convention will then elect Delegates and Alternates to the 10th U.S. Congressional District Republican Convention to be held on Saturday, **May 15, 2021**, at a location to be announced. Delegates and Alternates will also be elected to the State Republican Convention to be held on Friday and Saturday, **June 4-5, 2021**, at a location to be announced. Those who qualify and desire will also form the new County Committee (voting members) for 2021-2023.

Your participation in the 2021 Precinct Caucuses will strengthen the Barrow County Republican Party. With your help, we have made a major impact. The next election cycle has begun

JUST PLAIN STUBBORN

In a December interview defending his post-election inaction over alleged voting irregularities, Gov. Brian Kemp stated that "no one" worked harder for Donald Trump than he did. Hmm. I'm sure there are some longtime Trump friends, supporters and big dollar donors from Georgia who might beg to differ.

But let's take Kemp at face value. Why? Primarily because he is the first Republican governor of the state who started his political career as an actual Republican. And because it makes no sense that a man who owes his governorship to a tweet by President Trump would purposely blow his political brains out on purpose. As for all the nefarious motives attributed by rumor and innuendo to Kemp's refusal to get involved in straightening out Georgia's disastrous November election, they are crazy and off base.

You see, anyone who knows Brian Kemp knows that he is not devious or nefarious. Anyone who knows the governor knows that he is stubborn. I mean really stubborn. And when Kemp believes he is right about something, he doubles down on his stubbornness.

So when the governor decided that he should not be involved in calling for a special session of the General Assembly to address issues related to the Nov. 3 election and Jan. 5 U.S. Senate runoffs, that was that. The more leaders, including Trump himself, who called on him to do otherwise, the more Kemp dug in. I could have told them to save their collective breaths.

Kemp's logic was simple. Brad Raffensperger, whose future is either switching to the Democratic Party or serving one term as a Republican Secretary of State, was the sole constitutional officer in Georgia who could address alleged voting fraud. Whether he was correct or not will be in the hands on the voters in two years. After all, Raffensperger did order a signature audit – the day the electors made Joe Biden president and not in Fulton County, where the signature issue actually was one.

Now, before I write the rest of this column, let me insert this: FACT CHECK: "The Atlanta Journal-Constitution has determined that Georgia's general election was free, fair and without irregularities." Well, that closes that case, right?

MAJORITY OF REPUBLICANS THINK ELECTION UNFAIR

The fact is that, whether the *AJC*'s "fact checks" are correct or not, the vast majority of Republican voters in Georgia (in postelection polls) saw video from State Far, Arena, reports from sources as reputable as RealClearPolitics of large numbers of illegal votes cast and plenty of other examples of chicanery to believe that the election was not fair.

The *AJC's* own "debunking" of alleged shoddy signature checking skipped over the fact that the software purchased by Fulton County to validate those signatures somehow was never used in the November election. So 143,000 absentee voter envelopes were verified by hand in Fulton County. Right! "Fact checks" from Democrat-leaning media be damned, most Georgia Republicans still felt electorally robbed.

So the question is: How do Kemp and those who stood with him survive this meeting of the immovable object and irresistible force?

The betting odds right now would be against Kemp. There is no doubt, at present, that Trump would actively campaign against him and that Trump supporters from around the country would fill the coffers of a challenger in a GOP primary which Kemp could face in 2022. Current polling shows that any GOP opponent will start with around 40 percent of likely Republican voter support.

However, I didn't grow up as a child in the Georgia governor's office around the likes of Lester Maddox and Jimmy carter not to learn a thing or two long before I reached my General Assembly years and the likes of Zell Miller and Roy Barnes.

Georgia's governor is vested constitutionally with immense power. By this time next year there will be plenty of appointed positions to have been handed out and plenty of bills that required the governor's signature. Power has a way of taming the higher end of the political food chain, which often is the only end that needs taming.

If Trump considers another run for president, he might even come to recognize that fighting with a powerful governor is not the best move in a state that is so precariously on the edge of becoming blue.

CAN KEMP REGAIN HIS POLITICAL FOOTING?

My guess is that despite being stubborn, Kemp will power forward and regain his footing . . . at least enough to have more than a sporting chance in a primary fight. He has name identification and power that a lieutenant governor or secretary of state simply doesn't enjoy.

Yet, in a general election, Kemp will find a state now wedded to drop boxes and supervised by a secretary of state who flooded the place with absentee ballots and went to war with Trump. A "leader" who even delegated the training of election officials as to validity of absentee ballot envelope signatures to a Democratic chosen handwriting expert. The die has now been cast on Georgia's version of open and fair elections. That genie is out of the bottle.

And that gets me to Stacey Abrams. If anyone doubted how smart and able Abrams is, those doubts surely have melted away. Ultimately if Kemp proves a one-term governor, and ultimately if Republican majorities in Georgia disappear (even after controlling reapportionment, as Democrats did prior to Governor Barnes' defeat in 2002), it will be courtesy of Abrams and her vote turnout efforts.

That is because no matter how accommodating Republican leaders might have been to her in 2020, Abrams or her chosen surrogate will have no mercy on them in 2022. That means that Kemp will have to find every single supporter he can in order to pull off a re-election.

Brian Kemp must now stubbornly regain friends and search for a few new ones. I'm betting he can.

Mitch McConnell briefly blocked a resolution to organize the new Senate, demanding that it commit to keeping the filibuster for the next two years. He relented once two Democratic senators, Kyrsten Sinema of Arizona and Joe Manchin of West Virginia, issued new statement of their support for the institution. Both McConnell and Chuck Schumer declared victory. But some progressives fumed that Sinema and Manchin's position would doom their most important initiatives. McConnell, meanwhile, succeeded in slowing down the Democrats coming out of the gate. A small win, but a win. (*National Review*)
